

Conditions of participation for exhibitors at ConExPest_2017

1. The place, time and opening hours of the exhibition

3. Installation and dismantling of stands:

Conditions including the exact dates of installation and dismantling will be announced at a later date.

Stands and exhibitions may not be partially or fully dismantled until the closing of the exhibition.

In the event of breach of this condition, the organizers may impose a penalty on of 500Euro on the exhibitor and may refuse to book the future exhibitions at ConExPest.

4. Exhibitors registration:

Exhibitors who register until the December 31, 2016 shall receive a 10% rental discount.

Discount does not apply to any additional equipment surface or stand discount after December 31, 2016. The official registration of the exhibitor shall take place after payment of the full amount for the stand rental. The stand can be reserved by sending the registration form by fax or mail to the address of the Polish Pest Control Association. Registration and reservation of stands shall proceed in the order of applications.

The reservation is considered confirmed when the payment of 20% of rental and installation fee is sent to the account of the Polish Pest Control Association. In case of resignation from participation in the ConExPest 2017 exhibition the deposit for the reservation is not refundable. In case of not meeting the conditions of any complaints will not be considered and will not be the basis to act against the Organizer.

5. Participation and space rental costs:

The price includes the cost of renting 1 m² with standard installation. In case of not using part of provided materials the reimbursement for the unused materials is not provided.

The minimum exhibition area is 4m²:

4m² EUR 120 / m² net plus 23% VAT

6m² EUR 120 / m² net plus 23% VAT

8m² EUR 120 / m² net plus 23% VAT

12m² EUR 120 / m² net plus 23% VAT

16 m² EUR 120 / m² net plus 23% VAT

20 m² EUR 120 / m² net plus 23% VAT

25m² EUR 120 / m² net plus 23% VAT

Stand modules may be connected after consultation with the Organizer. And the maximum size of a stand for exhibitors may not exceed 32 m².

Supporting members and ordinary members of the Polish Pest Control Association is provided discount of 10%

(Discount is only granted to members upon payment due membership fees for the year 2017 until 31 December 2016).

Costs for additional media / equipment stands:

Comments:

- It is possible to rent additional media: electricity, water, internet, etc.

- It is possible to rent additional pieces of equipment stands

The costs of additional media and equipment to be agreed with the Organizer.

6. Conditions of payments

Payment for the rent of exhibition space and any additional equipment elements of the stand must be made by bank transfer to the account of the Polish Pest Control Association.

The fee for the stand must be received on the account of the Association no later than two weeks from the date of receipt of the invoice for the stand rental. The invoice may be delivered to the exhibitor by fax, e-mail, by mail or courier. If the fee is not received the booking is automatically canceled and the place is available for rent. The exhibitor must provide a payment confirmation to the Organizers.

7. Exhibitor passes

8. Preparation, installation and stand architecture.

The exhibitor is fully responsible for the exhibition stand. The floors, the walls of the hall, structural columns, elements of the water, electrical, and fire safety installations can not be painted, punctured and pasted in any way. Any damages resulting from non-compliance with this rule will be financially borne by the exhibitor. The size of the damage will be assessed by the owner of the facility and will not be subject to negotiations.

On the stands, accessing the structural columns should be available at any time. It is not allowed to build any installations on the columns.

9 Exhibition catalog and list of exhibitors and the insertion of advertising

The Organizers publish a list of all exhibitors on the ConExPest.pl website. The list will be available on the website until the page update for a period of at least 2 years.

The organizers will also provide a list of exhibitors for the exhibition visitors. The list in A5 format with instructions supplied by the exhibitor (maximum one page A5) will be available to visitors free of charge. Fair catalog will be created, it is possible to place an advertisement in the directory after consultation with the Organizer:
